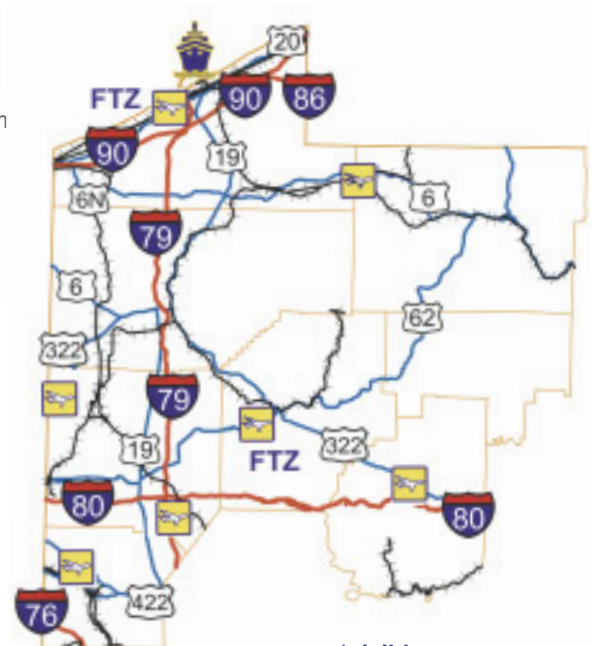

• **Trinity Point (155 acres, KOZ)** Trinity Point, designed for research and development, is shovel ready, high tech, and has three sources of high-speed internet. It features dual electrical feed, and is located directly on I-80, offering direct transportation access. Close connection with Clarion University benefits workforce and technology transfer.

• **Knowledge Park (200 acres)** Knowledge Park offers a superior technological infrastructure and close ties to Penn State Erie's strengths in applied research and technology transfer. Fiber-optic connectivity exists throughout the park, providing tenants with the most advanced communications technology to meet all voice, video, and data requirements.

• **Millennium Technology Park (530 acres, KOZ)** Easy access to I-80, I-76 & I-79 and is located 45 min. from Pittsburgh International Airport. It has 3 million gallons per day water capacity, high pressure gas line adjacent to site, excess sewer capacity, and TI lines available throughout service area.

Incentives

Keystone Opportunity Zones

KOZs represent the boldest, most forward-thinking economic development program in the nation. Through credits, waivers, and comprehensive deductions, **state and local taxes** on economic activity (such as sales taxes, corporate net income and property tax) in KOZs **are reduced to almost zero**. These tax abatements remain in effect through 2013.

Customized Training Programs

The third largest program in the nation, the Customized Job Training program is responsive to employer needs by **providing grant funds for specialized job training** to existing or newly-hired employees.

Guaranteed Free Training Program

Through the Workforce and Economic Development Network of PA (WEDnetPA), qualified companies may receive **free job training** for basic entry-level skills and advanced information technology skills for their employees.
